Prepare and Prevent, Don't Repair and Repent: Student and School Safety Issues in the Era of New Accountability

When a student presents as a potential risk to themselves or the school community, the Special Education Administrator is often relied upon to determine a decisive course of action. This session will focus on supporting school leaders and teams while keeping ALL safe in the school environment with discussion on:

- ✓ Developing the skills needed to assess threats of potentially harmful behavior and determine the level of concern and action required
- √ Successful systems for organizing resources to manage situations involving unsafe students
- √ Promoting and creating a sense of safety among students, teachers and parents
- ✓ Strategies and techniques for reducing the number of disciplinary exclusions for students who can be safely maintained in the school environment including de-escalation techniques and appropriate use and non-use of physical restraint and when to seek additional community resources for extreme unsafe situations
- √ Discussion of examples using assessments to make sound decisions including case studies illustrating defensible and non-defensible findings
- ✓ Best practices and skill building for Teams in ensuring student safety, assessing and responding to risk
- ✓ Challenges to the new accountability mandates and best practice to ensure school accountability
